# TRANSPARENCY AND OPENNESS IN UKRAINIAN CITIES: RESEARCH METHODOLOGY

Number and name of criteria to define a certain indicator. Every indicator is different and clearly connected to 1 of 13 methodology sections.

Maximum number of points and assessment criteria: 0 point — minimum number of points; 2 points — maximum number of points.

This methodology provides a detailed analysis of indicators according to which the number of points can reach the maximum points or a failing score (0). The overall number of points is 100.

Method of assessment used to award a certain number of points:

A — analytical conclusion of the research team;

D — ensuring standards of compliance adopted by the resolution of The Cabinet of Ministers N835 from 21.10.2015 on open datasets;

W — website analysis. The research clearly indicates there is sufficient information on the official website or other Internet resources on the City Council;

I — response to letter of inquiry;

T — Internet data;

S — complaints of citizens, court decisions, articles in the reputable mass media, public documents from NGOs (Non-Governmental Organizations), and deputies of the City Council.



This is a risk of increasing corruption at the local level. Therefore, it is very important at this stage to increase the transparency of cities, because without it, all the benefits of decentralization can be leveled.
